## OHSM 6013: HUMAN RESOURCES FOR OCCUPATIONAL HEALTH AND SAFETY

Learn the fundamental concepts and practices that are essential to human resource management. The importance of a human resource strategy will be addressed in this course with a focus on guidelines for effective human resource planning, recruitment, selection, compensation, and training in relation to the needs of Occupational Health and Safety professionals.

## **OHSM 6014: SAFETY MANAGEMENT**

This course will examine the critical components of an Occupational Health and Safety Management System including Risk Management, Hazard Recognition and Reporting. The primary goal of Safety Management is to develop programs that will reduce accidents, incidents and property / equipment damage. Although these programs are universal in health and safety, this class will look at Acts and Regulations specific the Province of Ontario.

## **OHSM 6023: MANAGEMENT SYSTEMS**

This course provides an introduction to the implementation strategies for Occupational Health and Safety Management Systems. This course will emphasize the importance of developing an effective internal responsibility system with the focus on the ISO 45001 standard as a framework.

## **OHSM 6024: WELLNESS AND REHABILITATION**

This course examines the structure and function of the Workplace Safety and Insurance Board (WSIB). The course will focus on the WSIB's role in promoting and managing health, safety, and wellness in the workplace and educating workplace parties about their roles and obligations as they relate to an injury or illness, modified work, and work reintegration. The course will

encompass new legislation as it relates to mental health. Workplace wellness will also be a focal point with respect to addiction and family assistance programs.

## **OHSM 6025: EMERGENCY PREPAREDNESS**

Emergency Management delves into the goals of an organization's emergency planning, with the specific aim of reducing personal injuries & property damage and returning the organization to post incident operational status. Emergency preparedness includes preparing: Emergency Response Plans or ERPs for spills, fires, serious injuries / illnesses (pandemics), severe weather or infrastructure damage; Business Continuity Plans or BCPs; Designating and training fire wardens / building designates; Communicating the plans to the employees; Developing workplace evacuation plans and muster points; Establishing a fire-prevention / fire suppression program; and controlling fire hazards.
