## FACULTY OF ARTS AND HUMANITIES

### ARTS AND HUMANITIES

Effective **September 1, 2013**, AH 3380E: *Critical Theories in the Arts and Humanities* will be introduced in the course offerings for the Faculty of Arts and Humanities.

#### **AH 3350/3380E: Critical Theories in the Arts and Humanities**

This course addresses the most recent contemporary theories and historical approaches currently used in the Arts & Humanities. It looks at how these theories can open up complementary ways of understanding and interpreting texts, objects, and historical contexts, while examining the potential of theoretical intersections amongst the disciplines.

Prerequisite: AH 2210E & AH 2220F/G

3 lecture hours, 0.5 course

### PHILOSOPHY

Effective **September 1, 2012**, Health Sciences 2610F/G: *Introduction to Ethics and Health* be made antirequisite to Philosophy 2071E: *Biomedical Ethics* and Philosophy 2715F/G: *Health Care Ethics*.

#### **Philosophy 2071E: Biomedical Ethics**

An introduction to ethical issues that arise in the delivery of health care such as human experimentation, informed consent, and the allocation of scarce resources. A case study approach is used with students offering and defending solutions to moral problems in these areas.

Antirequisite(s): Health Sciences 2610F/G

2 hours, 1.0 course

#### **Philosophy 2715F/G: Health Care Ethics**

An examination of key concepts in health care ethics, such as respect for patient autonomy, medical paternalism, patient competence, justice in health care, "death with dignity," "sanctity of life," commodifying human life. Goals are to understand these ideas and how to apply them to practical issues in health care.

Antirequisite(s): Health Sciences 2610F/G

3 hours, 0.5 course.

**BRESCIA UNIVERSITY COLLEGE****PHILOSOPHY**

Effective **September 1, 2012**, the following Philosophy courses be introduced at Brescia University College.

**Philosophy 3670F/G - The Philosophy of Existentialism: Atheistic and Religious Approaches**

This course focuses on one or more main thinkers or themes in Existentialism, including Kierkegaard, Nietzsche, Camus, Marcel, Sartre, and others. We will consider the human condition and situation, freedom, and the responsibility we have for our own lives. Is Existentialism essentially atheistic? How is human freedom reconciled with God?

Prerequisite(s): 3rd or 4th year standing in a Philosophy program.

3 hours, 0.5 course.

**Philosophy 3691F/G - Special Topics in the Philosophy of Religion**

**Philosophy 3700E – Ethics**

A critical study of moral problems and theories. The course will be based on readings selected from ethical literature from Aristotle to the present.

Prerequisite(s): Third or fourth year honors Philosophy status.

3 hours, 1.0 course.

**Philosophy 3996F/G - Topics in Philosophy**

An advanced reading course open to third or fourth year students registered in an Honors Specialization, Honors Double Major or Specialization module in Philosophy. Before registering the student must work out a detailed plan of study with a professor willing to supervise the student's work and have this plan approved by the Undergraduate Chair.

3 hours, 0.5 course.

**Philosophy 3997F/G Topics in Philosophy**

An advanced reading course open to third or fourth year students registered in an Honors Specialization, Honors Double Major or Specialization module in Philosophy. Before registering the student must work out a detailed plan of study with a professor willing to supervise the student's work and have this plan approved by the Undergraduate Chair.

3 hours, 0.5 course.

**Philosophy 3998E - Topics in Philosophy**

An advanced reading course open to third or fourth year students registered in an Honors Specialization, Honors Double Major or Specialization module in Philosophy. Before registering the student must work out a detailed plan of study with a professor willing to supervise the student's work and have this plan approved by the Undergraduate Chair.

3 hours, 1.0 course.

## CONTINUING STUDIES

### *DIPLOMA IN ARTS MANAGEMENT*

Effective **September 1, 2012**, ARMG 6012 Human Resource Management in the Arts be withdrawn from required diploma courses.

Effective **September 1, 2012**, ARMG 6007 be introduced to replace it as a required diploma course.

#### **ARMG 6007 - Volunteer Management**

This course will explore the roles of volunteers and their managers in arts organizations. Topics will include planning, recruitment, selection, orientation, training, supervision and assessment. Careful attention will be paid to legal and ethical considerations, and the relationship between staff and volunteers.
