Prerequisite(s): One or more of Ontario Secondary School MCF3M, MCR3U, or equivalent.

Anthropology 2216F/G CULTURES OF LATIN AMERICA ANTHROPOLOGICAL PERSPECTIVES ON LATIN AMERICA

The cultural history of Latin American societies. Topics include the historical formation of indigenous communities, and a wide variety of contemporary social problems in Latin America. A journey into the political and economic history of the region that pays attention to the daily lives, as well as the momentous struggles, of its culturally diverse inhabitants. Topics covered include economic dependency and exploitation, urban poverty, social stratification, "race", indigenous movements, state terror, peaceful resistance and revolution.

Effective, September 1, 2021, the following change(s) be made: Course Title or Description Revision.

Anthropology 2219F/G CULTURES OF THE MIDDLE EAST

A critical examination of approaches that tend to homogenize and dehistoricize Middle Eastern peoples. The course provides an historical overview that reveals regional heterogeneity, and shifts in peoples, powers and borders. Due to the immensity and complexity of the region, the thematic focus will change regularly.

An examination of the broad historical shifts and consequences of imperial domination reshaping people's social and cultural worlds in the "Middle East". Topics covered include: the rise of Islam including the Andalusian period, colonialism, Orientalism, media misrepresentations in western societies, class and gender, the Arab uprisings and popular culture.

Anthropology 2281F/G ANTHROPOLOGY OF INTERNATIONAL DEVELOPMENT

Third World responses to development from an anthropological perspective, with emphasis on the impact of market institutions on indigenous societies. Topics include the impact of aid, wage labor and urbanization on peasant communities; local versus national priorities in development; and risk aversion and technological innovation among small farmers.

An introduction to anthropological perspectives on international development. This course addresses the impacts of market institutions, international aid, wage labour, urbanization, and various industries on societies around the world, drawing attention to the distinctive perspectives and interests of people targeted by development initiatives.

Effective, September 1, 2021, the following change(s) be made: Course Title or Description Revision.

Anthropology 3305F/G HISTORY, TERRITORY AND THE POLITICS OF IDENTITY

This course examines the reconstitution of identities as people reclaim histories and territories, challenging nation-states and traditional identity references. The course examines different situations through case studies in colonial and post-colonial societies. Key issues to be discussed include: memory/history; territory, displacement and deterritorialization; citizenship, nation and the state.

The formation of collective identities is a process entwined with the production of historical narratives, especially in struggles against states, or to annex and dominate territories, or to secede from existing states. Based on case studies, the topics covered include: history/memory/identity-making, repression/resistance, displacement, nation-states and citizenship, sovereignty and territory.

Indigenous Studies 2216F/G CULTURES OF LATIN AMERICA ANTHROPOLOGICAL PERSPECTIVES ON LATIN AMERICA

A journey into the political and economic history of the region that pays attention to the daily lives, as well as the momentous struggles, of its culturally diverse inhabitants. Topics covered include economic dependency and exploitation, urban poverty, social stratification, "race", indigenous movements, state terror, peaceful resistance and revolution.

PSYCHOLOGY

Psychology 2020A/B DRUGS AND BEHAVIOR

Survey of the major drugs of abuse used to treat psychopathological disorders including a brief section on methods of administration, drug distribution and elimination, neurotransmitters. The history and patterns of use and abuse, clinic indications, neurochemical bases for action for a variety of licit and illicit drugs.

Survey of the major drugs of abuse, including alcohol, nicotine, caffeine, opiates, stimulants, inhalants, and sedative-hypnotics. Discussion will focus on historical and current patterns of use and abuse, behavioural and psychological effects of acute and chronic use, psychological

processes involved in drug effects, neurochemical bases for action, and treatment issues.
