3 lecture hours, 0.5 course.

### ECONOMICS

Effective **September 1, 2009**, Economics 2182F/G, will be changed from an essay course to a non-essay course: Economics 2182A/B and listed in the calendar. Also, the prerequisite will be changed from Economics 2151A/B to Economics 1021A/B and 1022A/B (or Economics 1020).

### FAMILY STUDIES

Effective **September 1, 2009**, Anthropology 2254G (Women in Prehistory) be added to the following three modules in the BA (Human Ecology) stream: the Honors Specialization in Family Studies, the Specialization in Family Studies, the Major in Family Studies, and the Minor in Family Studies.

9.0 courses

#### **MINOR IN FAMILY STUDIES**

4.0 courses

“0.5 to 1.5 courses” add Anthropology 2254G

Effective **September 1, 2009**, Family Studies 2220A/B (*Theoretical Perspectives in Family Studies Research*) and 2230A/B (*Qualitative Research in Family Studies*) are withdrawn and Family Studies 3220A/B and 3230A/B are introduced.

**Family Studies 2220A/B will be withdrawn.**

**Family Studies 2230A/B will be withdrawn.**

**Family Studies 3220A/B will be introduced.**

Family Studies 3220A/B, *Theoretical Perspectives in Family Studies Research*

Students will be introduced to the major theoretical frameworks used by social scientists to explain variation in family life including life span, life course, developmental, social learning, social exchange, social conflict, symbolic interactionist, ecological, family systems and feminist theory perspectives.

Antirequisite(s): The former Family Studies 2220A/B.

Prerequisite(s): Family Studies 1020 or permission of the instructor.

3 lecture hours, 0.5 course. (Brescia)

**Family Studies 3230A/B will be introduced.**

Family Studies 3230A/B, *Qualitative Research in Family Studies*

An introduction to qualitative research and its application to the study of the family. Topics to be considered include participant observation, interview skills, life histories and methods of analysis.

Antirequisite(s): The former Family Studies 2230A/B.

Prerequisite(s): Family Studies 1020 or permission of the instructor.

3 lecture hours, 0.5 course. (Brescia)

**Add 3220A/B and 3230A/B as prerequisite(s) for Family Studies 4450A/B-4452A/B**

Effective **September 1, 2009**, *Writing 1020F/G* or *Writing 2101F/G* be added as a required course to the three modules in the BA (*Human Ecology*) stream, and to the Minor in Family Studies as well.

Effective **September 1, 2009**, Family Studies 2200E (*Current Issues in Family Studies*), FS 2225E (*Immigration and the Family Experience*), and FS 3325A/B (*The Diversity of the Canadian Family*).

**Family Studies 2200E, Current Issues in Family Studies**

"This course focuses on current issues involving the family. Factors which currently impact on families, including their form, functions, stresses, and changes, will be examined in depth. Emphasis will be on families in Canada, with attention to Canadian diversity, as well as internationally comparative work.

Prerequisite(s): Family Studies 1020 or permission of the instructor.

3 lecture hours, 1.0 course. (Brescia)"

**Family Studies 2225E, Immigration and the Family Experience**

"This course examines family practices cross-culturally, especially how they are affected by immigration.

Many issues facing immigrant families are covered including childrearing, parenting, gender relations, ethnic

identity, and sociocultural adaptation to immigration and settlement. Immigration history, policies, and settlement programs related to families in Canada will be examined.

Prerequisite(s): Family Studies I020 or permission of the instructor.

3 lecture hours, 1.0 course (Brescia)"

**Family Studies 3325B Diversity and the Canadian Family** (*Please note change in title as well*)

"This course examines contemporary diversity as it impacts individuals and families. Its psychosocial approach enables students to think through their own perspectives on race, ethnicity, religion, sexual identity, and more. This course focuses upon understanding families' strengths and challenges in contemporary society, and efforts to support families and children.

Prerequisite(s): Family Studies 2200E or 2225E or permission of the instructor.

3 lecture hours, 0.5 course. (Brescia)"

*Effective **September 1, 2009**, the Essay Course Status of Family Studies 2225E, Immigration and the Family Experience, will be changed to the Non-Essay Course Status.*

**Family Studies 2225, Immigration and the Family Experience**

Diversity in culture of origin and family form lead to diversity in parenting and child care in Canada. The course examines the differing expectations of children, and parents and teachers across cultures, migration and settlement experience, related family resources and government policies.

Antirequisite(s): The former Family Studies 2225E.

Prerequisite(s): [Family Studies 1020](#) or permission of the instructor.

3 lecture hours, 1.0 course. (Brescia)

The "E" designation will be removed from the course number in the official course listing, and from all the Family Studies modules.

## SOCIOLOGY

*Effective **September 1, 2009** the description of the Major in Sociology will be different from the description of the Major in Sociology in the Faculty of Social Science section of the Calendar (p. 211), to which it referred for reasons of convenience. The Brescia description should now include the words "and above" to the two "2.0 courses" categories. It would read:*

**MAJOR IN SOCIOLOGY**

"2.0 courses in Sociology numbered 2200 and above."

"2.0 courses in Sociology numbered 2100 and above."

The revised Brescia module description should therefore be moved to the Affiliated University Colleges section of the Calendar (and not just linked to the main campus module).
