FACULTY OF ARTS AND HUMANITIES

CLASSICAL STUDIES

Effective September 1, 2009, Classical Studies 2904A/B, 2905A/B and 2906A/B, all entitled Special Topics in Classics Studies, will be introduced in the Faculty of Arts and Humanities.

Classical Studies 2904A/B: Special Topics in Classical Studies
2 lecture hours, 0.5 course.

2 lecture hours, 0.5 course.

ENGLISH

Effective September 1, 2009, English 1027F/G: The Storyteller's Art I: Introduction to Narrative, and 1028F/G: The Storyteller's Art II: Topics in Narrative, will be introduced in the Faculty of Arts and Humanities. These half courses will be taught on main campus and at all three affiliated colleges.

English 1027F/G: The Storyteller's Art I: Introduction to Narrative
Storytelling defines who we are and our relation to the community, the nation, and the world. This course explores the rich and diverse traditions of storytelling: such as, oral tales, short stories, classic fiction, and graphic novels. Instruction by lecture and tutorials; emphasis on developing strong analytical and writing skills.

Antirequisite(s): English 1024E, 1036E

Prerequisite(s): Grade 12U English or permission of the Department. For part time students who have been admitted without the OSSD, this permission will be granted as a matter of course.

3 hours, 0.5 course.

English 1028F/G: The Storyteller's Art II: Topics in Narrative

This course explores a particular theme, mode, or genre of storytelling. Consult the Department of English for details of current course offerings. Instruction is by lecture and tutorials; emphasis on developing strong analytical and writing skills.

Antirequisite(s): English 1024E, 1036E

Prerequisite(s): Grade 12U English or permission of the Department. For part time students who have been admitted without the OSSD, this permission will be granted as a matter of course.

3 hours, 0.5 course.

Effective September 1, 2009, the Minor in English for Teachers will be revised to include honors-level English courses numbered 2999 and above.

MINOR IN ENGLISH FOR TEACHERS

Admission Requirements

Completion of first-year requirements, including 1.0 course from English 1020E, 1022E, or 1024E with a mark of at least 60%. Students should consult with the Department prior to admission.

FILM STUDIES

Effective September 1, 2009, Film Studies 2252E: Movements in European Film, will be withdrawn from course offerings in the Faculty of Arts and Humanities and Film Studies 2250F/G: Movements in European Film, will be introduced to replace it. The Honors Specialization, Specialization and Major in Film Studies modules, and the Minor in National Cinemas module, will be revised to reflect the change in the specified course's weight and number.

Film Studies 2250F/G: Movements in European Film

This course offers an introduction to issues of aesthetics, culture, and history relevant to important movements in European film such as German Expressionism, Soviet Montage, Poetic Realism, Italian Neorealism, the French New Wave, New German Cinema and the Dogma movement.

Prerequisite(s): At least 60% in Film Studies 1020E, or permission of the Department.

2 lecture/seminar hours, 1 3-hour lecture/screening, 0.5 course

WRITING

Effective September 1, 2009, Writing 2200F/G: Writing Proficiency Examination, will be withdrawn from course offerings in the Faculty of Arts and Humanities.

Effective September 1, 2009, Writing 2215F/G: Rhetorical Theory, and 2216F/G: Legal Rhetoric, will be introduced in the Faculty of Arts and Humanities.

Writing 2215F/G: Rhetorical Theory

This course introduces students to basic precepts of rhetorical theory, and their application to communication analysis and the practice of writing. Topics will include rhetorical argumentation, 'publics' theory, and conceptions of rhetoric as both a social practice and a method.

Antirequisite(s): Writing 2292F (2008-2009); Writing 292F if taken in 2007-2008 or in 2005-2006

Prerequisite(s): At least 65% in one of Writing 2101F/G, 2111F/G, 2121F/G, or 2131F/G, or permission of the program.

3 lecture hours, 0.5 course.

Writing 2216F/G: Legal Rhetoric

This course examines the forms and function of rhetoric in legal discourse and debate. Principles drawn from rhetorical theory, ancient and modern, will be tested through their application to legal texts drawn from various sources, including trial transcripts, and academic and public commentary on legal issues.

Antirequisite(s): Writing 2293G (2008-2009); Writing 293G if taken in 2007-2008 or 2006-2007.

Prerequisite(s): At least 65% in one of Writing 2101F/G, 2111F/G, 2121F/G, or 2131F/G, or permission of the program.

3 lecture hours, 0.5 course.

Effective September 1, 2008, the Minor in Creative Writing will be revised to remove the requirement for "1.0 course in English (not including 2998E and 4999E) or Film Studies at the 2100 level or above" and replace it with a requirement for "1.0 course in English (not including 2998E and 4999E) or Film Studies at the **2000** level or above".

HURON UNIVERSITY COLLEGE**MANAGEMENT AND ORGANIZATIONAL STUDIES**

Effective September 1, 2009, MOS 4460A/B: Advanced Accounting I, and 4461A/B: Advanced Accounting II will be introduced at Huron University College

Management and Organizational Studies 4460A/B: Advanced Accounting I

Advanced financial accounting topics including international accounting and Canadian accounting treatment of intercorporate investments, business combinations, foreign currency transactions and translation, and entities in financial difficulties.

Antirequisite(s): Business Administration 4427A/B, the former Administrative Studies 362a/b, 460a/b.

Prerequisite(s): Management and Organizational Studies 3361A/B and enrolment in the BMOS program.

3 lecture hours, 0.5 course.

(King's, Huron)

Management and Organizational Studies 4461A/B: Advanced Accounting II

Advanced financial accounting topics including Canadian accounting for partnerships, not-for-profit organizations and financial statement analysis.

Antirequisite(s): The former Administrative Studies 363a/b, 461a/b.

Prerequisite(s): Management and Organizational Studies 4460A/B and enrolment in the BMOS program.

3 lecture hours, 0.5 course.

RELIGIOUS STUDIES

Effective September 1, 2009, Huron University College will introduce Religious Studies 2301F/G: Interpreting Abraham, 2310F/G: Interpreting the Qu'ran, 2320F/G: Interpreting the Hebrew Bible, and 2330F/G: Interpreting the Christian Bible

Religious Studies 2301F/G: Interpreting Abraham

This course examines religious texts (in translation) where Abraham is portrayed as the founder of peoples—the Tanakh, the Christian Bible, and the Qu'ran. The classic texts, images, and narrative of Abraham's story will be studied, as well as the interpretive methodologies employed in the Jewish, Muslim, and Christian traditions.

3 lecture hours, 0.5 course

(Huron)

Religious Studies 2320F/G: Interpreting the Hebrew Bible (Tanakh, in translation)

This course explores the rich and sometimes problematic relationship between text, context, and community in relation to selected passages from the Hebrew Bible. In addition to textual analysis, the course covers the history of reception and the influence these texts and their interpretations have on social relations and contemporary issues.

3 lecture hours, 0.5 course

(Huron)

Religious Studies 2330F/G: Interpreting the Christian Bible (in translation)

This course explores the rich and sometimes problematic relationship between text, context, and community in relation to selected passages from the Christian Bible. In addition to textual analysis, the course covers the history of reception and the influence these texts and their interpretations have on social relations and contemporary issues.

3 lecture hours, 0.5 course

(Huron)

Religious Studies 2310F/G: Interpreting the Qu'ran (in translation)

This course explores passages in the Qu'ran that have shaped classical and contemporary Islam, particularly regarding the tensions between text, context, and community. In addition to textual analysis, the course covers the history of reception and the influence these texts and their interpretations have on social relations and contemporary issues.

3 lecture hours, 0.5 course

FACULTY OF SCIENCE**APPLIED MATHEMATICS**

Effective September 1, 2009, Applied Mathematics 2503A/B: Advanced Mathematics for Statistics, will be introduced by the Faculty of Science.

Applied Mathematics 2503A/B: Advanced Mathematics for Statistics

Modelling deterministic systems with differential equations. Laplace transforms. Moment generating functions. Review of matrices. Eigenvalues and eigenvectors, systems of linear differential equations. Markov processes.

Prerequisite(s): Calculus 2402 A/B or Calculus 2502 A/B and Mathematics 2123 A/B, Linear Algebra 1600 A/B or Applied Mathematics 1411 A/B, Statistical Sciences 2657A or Economics 2122 A/B. In each course a minimum mark of 60% is required.

3 lecture hours, 0.5 course.

Effective September 1, 2009, Applied Mathematics 3613B: Mathematics of Financial Options, will be revised by the Faculty of Science.

Applied Mathematics 3613B: Mathematics of Financial Options

An introduction to modern financial mathematics using a differential equations approach. Stochastic differential equations and their related partial differential equations. The Fokker-Planck and Kolmogorov PDEs. No-arbitrage pricing, the Black-Scholes equation and its solutions. American options. Exotic options.

Prerequisite(s): Applied Mathematics 3413 A/B.

3 lecture hours, 0.5 course.

Effective September 1, 2009, the prerequisites to Applied Mathematics 3815 A/B: Partial Differential Equations I, will be revised to read as shown below.

Applied Mathematics 3815 A/B: Partial Differential Equations I

Boundary value problems for Laplace, heat, and wave equations; derivation of equations; separation of variables; Fourier series; Sturm-Liouville Theory; eigenfunction expansions; cylindrical and spherical problems; Legendre and Bessel functions; spherical harmonics; Fourier and Laplace transforms. (35 words)

Prerequisite(s): (i) Linear Algebra 1600 A/B, Differential Equations 2402A, Calculus 2303 A/B or Calculus 2503 A/B; or (ii) Calculus 2402 A/B and Applied Mathematics 2503 A/B. In each course a minimum mark of 60% is required.

3 lecture hours, 0.5 course.

Effective September 1, 2009, the prerequisites to Applied Mathematics 3817A/B: Optimization, will be revised to read as shown below.

Applied Mathematics 3817A/B: Optimization

An introduction to linear programming, simplex method, duality theory and sensitivity analysis, formulating linear programming models, nonlinear optimization, unconstrained and constrained optimization, quadratic programming. Applications.

Prerequisite(s): Linear Algebra 1600A/B and one of Calculus 2303A/B, 2503A/B, or 2402A/B.

3 lecture hours, 0.5 course.

CALCULUS

Effective September 1, 2009, Calculus 2402 A/B: Calculus with Analysis for Statistics, will be introduced and offered jointly by the Department of Applied Mathematics and the Department of Mathematics in the Faculty of Science.

Calculus 2402 A/B: Calculus with Analysis for Statistics

Functions of multiple variables and their differential calculus. The gradient and the Hessian. Constrained and unconstrained optimization of scalar-valued functions of many variables: Lagrange multipliers. Multidimensional Taylor series. Integrating scalar-valued functions of several variables: Jacobian transformations. Pointwise and uniform convergence. Power series.

Antirequisite(s): Calculus 2302 A/B, Calculus 2502 A/B or the former Applied Mathematics 290A.

Prerequisite(s): Calculus 1501 A/B or Calculus 1301 A/B or Applied Mathematics 1413, in each case with a minimum mark of 55%.

3 lecture hours, 0.5 course.

EARTH SCIENCES

Effective September 1, 2008, the Honors Specialization, Specialization and Minor modules in Geophysics and the Specialization module in Environmental Geoscience will be revised to replace ES2221A/B with 3320A/B: Environmental and Exploration Geophysics II. (Earth Sciences 2221A/B, Environmental and Exploration Geophysics II course will be removed and the new course, Earth Sciences 3320A/B: Environmental and Exploration Geophysics II, will be introduced to meet the demand for higher level material on geophysical techniques.

KINESIOLOGY

Effective September 1, 2009, Kinesiology 3020A/B: Certification for National Lifeguard Service (NLS) - Pool Option Course, will be introduced in the School of Kinesiology in the Faculty of Health Sciences.

Kinesiology 3020A/B: Certification for National Lifeguard Service (NLS) - Pool Option Course
 This course is based on the Life Saving Society's National Lifeguard Service (NLS) Pool Option Course. NLS is a legal certificate for lifeguarding throughout Canada and is the only lifeguard certificate recognized by the province of Ontario. Participants will be introduced to lifeguard theory, communication, accident prevention, supervision of an aquatic facility, scanning, positioning and rotation as well as in-depth emergency situations.

Antirequisite(s): Life Saving Society National Lifeguard Service (NLS) certification (pool, water front, water park and/or surf) through any organization.

Prerequisite(s): Completion of the first-year Kinesiology program and registration in the School of Kinesiology; Kinesiology 2215Q/R/S/T (Swimming Skills) OR Life Saving Society Bronze Cross certification (documentation must be shown to instructor on the first day of class).

5 lecture/lab hours per week, 0.5 course

Note: To receive the National Lifeguard Service (NLS) certification, a student must attain a minimum final grade of 75% and complete all components of the course successfully. Students will be required to pay a NLS certification fee.

FACULTY OF EDUCATION

TECHNOLOGICAL EDUCATION COURSES IN COMPUTER TECHNOLOGY, GREEN INDUSTRIES, HEALTH CARE, AND HAIRSTYLING & AESTHETICS

 Critical analysis, organization and presentation of the subject matter involved in technological studies. Curriculum development based on contemporary theory and on the requirements of the particular environment of the technology studies classroom/workshop. Attention to experiential theories of learning, adolescent development, and student diversity.

4 lecture hours, 1.0 credit

Teaching and Learning Theory in [area of specialization]: Instructional Strategies
 Theory, methods, and techniques of establishing a positive learning environment in the technological education classroom/workshop. Teaching methodologies appropriate for young people and adults are studied in the context of experiential learning theory. Attention to experiential theories of learning, adolescent development, and student diversity.

4.0 lecture hours, 1.0 credit

Effective January 1, 2009, EDUC 5116, Curriculum and Pedagogy in Aboriginal Studies (Junior/Intermediate) and EDUC 5224, Curriculum and Pedagogy in Aboriginal Studies (Intermediate/Senior) will be introduced in the Faculty of Education.

5116 Curriculum and Pedagogy in Aboriginal Studies (Junior/Intermediate)

An introduction to Aboriginal Studies as a school subject in elementary schools. Curriculum, pedagogical approaches, relevant theories of teaching and learning, and issues in Native Studies education are examined.

2 lecture hours, 0.5 course

5224 Curriculum and Pedagogy in Aboriginal Studies (Intermediate/Senior)

An introduction to Aboriginal Studies as a school subject in secondary schools. Curriculum, pedagogical approaches, relevant theories of teaching and learning, and issues in Native Studies education are examined.

FRENCH

Effective September 1, 2009, French 3800A/B: French Applied Linguistics, will be introduced at Brescia University College.

French 3800A/B: French Applied Linguistics

This course provides students with relevant research in second language acquisition by explaining how languages are learned. It introduces some theories and discusses various approaches, outcomes and issues related to teaching.

Prerequisite(s): French 2900 or by permission of the Department.

Sociology 3404F/G: Modern Sociological Theory

This course will survey major trends in modern sociological theory.

Antirequisite(s): Sociology 4404F/G

Effective September 1, 2009, Sociology 3404F/G: Modern Sociological Theory will replace Sociology 4404F/G: Modern Sociological Theory I, as a required course for the Honors Specializations in Sociology and

Effective September 1, 2009, Sociology 4421F/G: Race and Minority Relations, and 4420F/G: Race, Class and Colonialism, will be introduced in the Faculty of Social Science.

Sociology 4421F/G: Race and Minority Relations

This course invokes the political economy and political sociology of identity and will use the concepts of primordialism, globalization and ethnic entrepreneurship as its points of departure to assess how such claims to belonging as race, minority status, culture, and nationalism inform politically correct behaviour in contemporary society.

Antirequisite(s): Sociology 485F/G if taken in 2005-06, 2002-03, 2000-01, 1998-99.

Prerequisite(s): Enrolment in fourth year of one of the Honors Specializations or Honors Double Major in Sociology.

3 seminar hours, 0.5 course.

Sociology 4420F/G: Race, Class and Colonialism

In analyses of social inequality the concept of class has been assigned a pivotal role, recently it has been overshadowed by the term race. Focusing on colonial expansion, slavery and indenturedship, this course will explore the multi-dimensional features of power struggles along lines of class, "race," ethnicity, culture, and nation.

Antirequisite(s): Sociology 485F/G or 4485F/G if taken in 2008-09, 2006-07, 2004-05, 2001-02, 1999-00, 1997-98.

Prerequisite(s): Enrolment in fourth year of one of the Honors Specializations or Honors Double Major

in Sociology.
3 seminar hours, 0.5 course.
