PHYSICAL ACTIVITY SKILLS AND COACHING COURSES

Kinesiology Physical Activity Skills and Coaching courses refer to the following Kinesiology courses: Kinesiology 2200A/B, 2201A/B, 2202Q/R/S/T - 2225Q/R/S/T, 3300A/B, 3301A/B, 3302Q/R/S/T - 3329Q/R/S/T.

Each of Kinesiology 2020Q/R/S/T-2025Q/R/S/T, 2202Q/R/S/T - 2225Q/R/S/T and 3302Q/R/S/T - 3329Q/R/S/T, is a 0.25 course, five lecture/lab hours per week for a six-week term. The six-week term is designated with the suffix Q, R, S or T. A maximum of four Physical Activity quarter courses (or equivalent) must be selected in each of second and third year. One quarter course per six-week term may be taken during any academic year. No more than twelve 0.25 (or equivalent) activity courses are allowed in any Kinesiology degree.

Prior to graduation, a student must complete a minimum of eight 0.25 courses (or equivalent) in all Kinesiology degree programs, unless designated otherwise.
